\$8M PLACEMENT NOTICE UNDER SECTION 708A(5)(e) OF THE CORPORATIONS ACT

Further to the announcement released to ASX on 27 March 2017, the Directors of Creso Pharma Limited (ASX: CPH) (**Company**) provide a notice for the purposes of section 708A(5)(e) of the Corporations Act 2001.

As part of the Placement to raise \$8m, a total of 8,158,750 fully paid ordinary shares were issued to professional and sophisticated investors at an issue price of A\$0.69 per Share under the Company's 15% Placement Capacity under Listing Rule 7.1.

The Shares are part of a class of securities quoted on ASX and may be subject to a subsequent offer for sale. The Company issued the Shares above without a disclosure document to investors under Part 6D.2 of the *Corporations Act 2001* (Cth) (the **Act**).

As at the date of this notice, the Company has complied with:

- a) the provisions of Chapter 2M of the Act as they apply to the Company; and
- b) section 674 of the Act.
